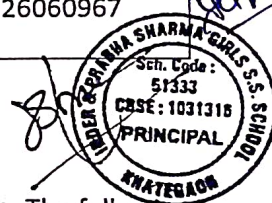

## Anti Ragging Committee



Inder and Prabha Sharma girls' school has constituted the anti-ragging committee. The following instruction are framed to prevent the menace of ragging and foster healthy interpersonal relations along students in the campus of school.

Anti ragging committee to ensure compliance with the provision of rules regulations as well as the provision any law for the time being in force concerning and also, to monitor and oversee the performance of Anti Ragging squad in prevention of ragging in the school premise: -

- Any act of indiscipline, teasing or handling with rudeness.
- Any activity which is likely to cause annoyance, hardship, psychological harm or creates fear or apprehension.
- Any act of financial extortion or forceful expenditure.
- Any act of physical abuse causing assault, harm or danger to health.

- Any act of abuse by spoken words, emails, SMS or public insult etc.
- Any act of wrongful confinement, kidnapping, molesting or committing unnatural offences, use of criminal forces, trepas or conspiracy to ragging.

### **Punishment to those found guilty**

- Any Student or group of students found guilty of ragging in the campus or even outside the campus shall be liable to one or more of the following punishment:-
- Debarring from appearing in any sessional test / school board examinations suspension from attending classes & academic privileges.
- Suspension from the school / Hostel for a period of one month.

### **Objective of anti-Ragging committee**

- Anti ragging committee responsibilities for inculcating culture of ragging free environment in the campus.
- Anti ragging committee will be in designing strategies action plan for curbing the menace of ragging in the school premise by adopting away of activities.

### **Responsibilities of Anti Ragging Squad: -**

- Anti ragging squad will be working under the monitoring of anti-ragging committee and will seek advice from the anti-ragging committee.
- The squad will also educate the students at large by adopting various means about the menace of ragging and relates punishment there to.

A gamut of positive reinforcement activities are adopting by anti-ragging squad for orienting students.

They shall work in consonance guidance of anti-ragging committee.

### **Functions of Committee: -**

- To consider the complaints received from the students & conduct enquiry & submit report to anti ragging committee along with punishment recommend for the offenders: -
- Oversee the procedure of obtaining undertaking from the St. in accordance with the provisions.
- To create awareness among the St. about anti ragging.
- To take all necessary measures for prevention of ragging inside the campus / hostel.
